## 2017 RENEWAL SWEEPSTAKES

## **OFFICIAL RULES**

3. How to Enter: If you were a Cleveland Browns season ticket member during the 2016 NFL season, receive one (1) Official Entry Form by making a payment towards your purchase of your 2017 season tickets during the Promotion Period. If vou were not a Cleveland Browns season ticket member during the 2016 NFL season, receive one (1) Official Entry Form by mailing a postcard with proper postage affixed to 2017 Renewal Sweepstakes, c/o Cleveland Browns, 76 Lou Groza Blvd., Berea, OH 44017. Each entry must be received during the Promotion Period and prior to the close of the Entry Period to be eligible for that Entry Period's drawing. Any postcard(s) submitted must be legible and contain the following information: the entrant's full name, address, and phone or email.
